We're offering below a simple idea which, when completed by December 31, provides you with additional tax benefits, whether you choose the Aviary or another charitable cause.

#### Gifts of Life Insurance

Do you own life insurance policies that have cash value but are no longer needed for their original purposes? These can make convenient tax-deductible charitable gifts and provide an excellent way to make a gift in honor or memory of a loved one. Simply contact the carrier of your policy and state that you need a policy change form for change of ownership and beneficiary designation. Forms among carriers vary in name, so just be sure to state that you want to name a charity as both the owner and beneficiary of the policy. Giving paid-up life insurance entitles those who itemize to an income tax charitable deduction equal to the cash value of the policy, or the actual cost basis (premium payments made), whichever is less. Should you choose to name the National Aviary as the beneficiary, you automatically become a member of the Phoenix Society, the legacy society of the National Aviary.

#### **Did You Know?**

For individuals over 70½ in either 2006 or 2007 who have an IRA, the Pension Protection Act of 2006 provides for up to \$100,000 of direct distributions from IRAs to charities without inclusion in income during both 2006 and 2007. See your tax advisor for details.

We have stock and mutual fund transfer instructions available as well as other information to expedite your year-end gift giving.
